- Order created (single)
- Orders uploaded (via CSV)
- Order withdrawn
- Company Trade formed
- Trade formed for delivery today or tomorrow
- Next Day Delivery Summary

The primary audience for this document are customer technology staff who wish to script the extraction of important information from these messages into proprietary systems.
